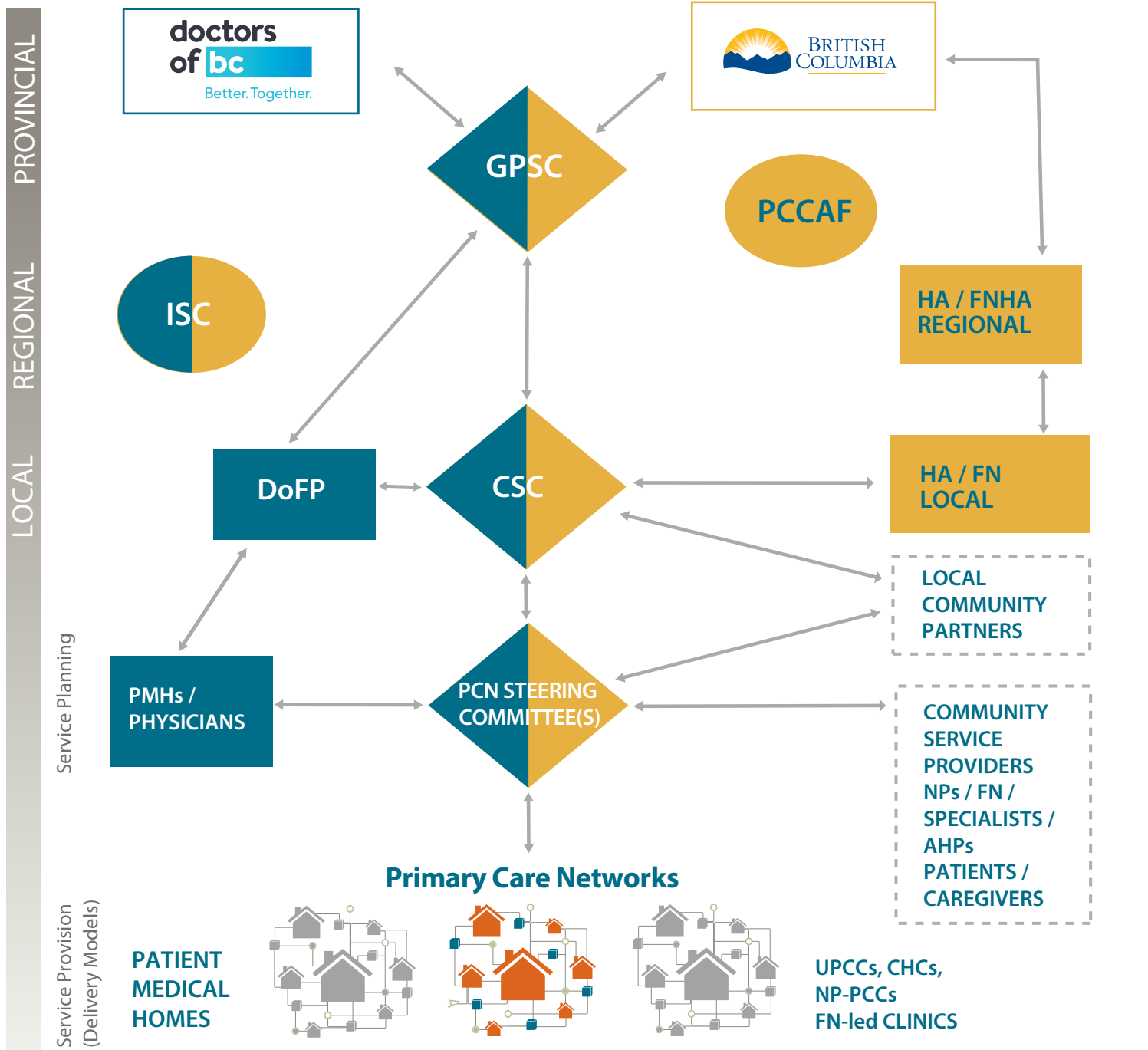

## DECISION-MAKING COMMITTEES

### General Practice Services Committee (GPSC)

*Co-led by Doctors of BC and the Ministry of Health*

- Ministry of Health
- Doctors of BC
- Regional Health Authorities
- Divisions of Family Practice
- First Nations Health Authority (FNHA)
- Nurses and Nurse Practitioners of BC (NNPBC)
- Society of General Practitioners of BC

**GPSC:** *A collaborative partnership of the Government of BC and Doctors of BC. Works to strengthen full service family practice and the provision of quality patient care by GPs. It also supports the integration and alignment of physician services with other health service delivery, and promotes collaborative practice in meeting the needs of the population.*

### Collaborative Services Committee (CSC)

*Co-led by Health Authority and Divisions  
+ First Nations in some communities*

**CSC:** *Provides PCN strategic leadership for the establishment of local PCN Steering Committee(s), PCN design and implementation, SCSP alignment, and analysis of data to help identify community care needs and outcomes.*

### Primary & Community Care Advisory Forum (PCCAF)

*Chaired through the Ministry of Health*

**PCCAF:** *A collaborative, provincial forum of partners that advises MOH decision making about health system transformation in BC. Partners share information, progress, challenges and advice about the implementation of policy including PCNs, UPCCs and CHCs, and SCSPs.*

### Interdivisional Strategic Council (ISC)

*Co-led by Health Authority and Divisions  
and supported by the GPSC*

- Divisions of Family Practice
- Regional Health Authorities
- *Other provincial and regional partners may be invited to join ISCs*

**ISC:** *A regional forum that includes representatives of all division and health authority primary and community care leads within a region. Provides an opportunity for regional strategic discussions and alignment regarding PMH, PCN, and health authority services.*
